Child Care: The Key To The North Country's Economy ...

On September 29th, Dee Burlingame and I participated in the NYS Early Care & Learning Council's CCR&R Leadership Summit as we do each and every year. Roberta Reardon was one of the featured keynote speakers that She noted how New day. York State had lost 42% of its Early Childhood workforce between 2019 and 2021. Some of that is directly attributed to the COVID-19 pandemic where many child care programs closed and never reopened leaving families with few options.

The world has changed so much since early 2020. We still have COVID in our communities, many parents are working remotely from home and some will remain that way permanently, schools were and may again be constantly opening and closing leaving families with a never

ending struggle to find child care. When and if they could not find care they were often forced to leave the workforce.

Every day we heard or read stories about the essential workers who were on the front lines keeping us safe and keeping our economy alive. Unfortunately, amidst all the television and social media ads thanking those essential workers we rarely, if ever, heard mention of those of you who cared for the children of those essential workers.

I want you to know that we, at the St. Lawrence Child Care Council, have carried and shared that message at every opportunity we had. Whether it was on ZOOM meetings, conference calls, in media requests, etc. we repeated the message that child care was critical infrastructure key to keeping North Country families working In July of 2020 the SLCCC was contacted by Sen. Kirsten Gillibrand's staff

asking us to facilitate a press conference in Ogdensburg to announce her sponsorship of the "Child Care is Essential" bill in the U.S. Senate.

Our voices were not alone. There were many others across the state and country who were continually lifting up those of you who work in Early Childhood as a cornerstone for economic recovery and growth. When people were unable to return to work because of a lack of child care employers were forced to accept that child care was no longer "a family or women's issue." If these workforce development issues were going to change so to did the decades old attitudes about child care.

Fortunately, child care is now part of most workforce and economic development conversations in St. Lawrence County. We are optimistic there will be significant local efforts for the expansion of existing and creation of new child care programs in the months ahead.

Keeping You Informed Helps Keep You in Compliance ...



"Are you in compliance? Our safety depends upon you!"

Changes in regulations and new policy statements seem to take programs by surprise, but they need not do so. Both are available to anyone at anytime online at the NYS website https:// ocfs.ny.gov/programs/ childcare/info-forproviders.php click on the Info For Providers banner and you will find regulations for all modalities of child care and don't forget to check the policy statements!!!! The policy statements provide excellent information you may not have seen before. NYSOCFS will also send a "Dear Provider Letter" to all programs whenever significant changes occurs.

Let's take a quick look at one recent change ...

Elijah's Law ...

Are you in compliance? The deadlines have passed!

In 2019, New York State legislation adopted new called "Elijah's Law". law is named after 3-year-old Elijah Silvera from New York City who was given a grilled cheese sandwich while at day care despite having a known severe dairy allergy. Elijah went into anaphylaxis, his family was not told what he had eaten and 911 was not called. Elijah died in November 2017. Implementation of Elijah's Law requires changes to your child care program, valuable, potentially life saving changes that are intended to prevent further tragedy.

As a child care professional, you play a critical role in protecting the health and safety of the children in your pro-On August 19, 2021 gram. NYSOCFS sent a second Dear Provider Letter reminding all programs what must be done in order to be in compliance. Here is the link to that letter:

A Word About Email ...

ALL licensed or registered child care providers and programs are required to have an email address on file with the state. Earlier this year SLCCC staff contacted all programs in St. Lawrence County to make sure your email address was correct in the state database.

NYSOCFS is no longer sending Dear Provider Letters via the US Mail. Instead, all communications are being sent via email they are also posted to the NYSOCFS website.

In order to stay informed you must check your email of record on a regular basis. Staying informed helps keep you in compliance ... this means you have a responsibility to check your email on a regular basis and monitor the NY-SOCFS website periodically to stay ahead of changes.

We will also do our part by informing you of changes as soon as we know of them. As always, if you have any questions contact the SLCCC!
